### Secretary's Report

19-20 Fiscal Audit – The 19-20 audit report has been issued without audit findings. Audit Synopsis has been provided to the Board. The purpose of the audit synopsis is to provide you with a general overview/snapshot of the district financial position for the 19-20 fiscal year. The first few pages are the balance sheet with the assets and liabilities balances. Second Section is the income statement.

One of the most substantial audit statements is the audit schedule C. This schedule outlines the revenues and budgeted amounts per account, along with the amount spent in those accounts. The bottom section of this schedule tallies all of the excess revenues and expense account balances to determine how the year ended.
