Mr. Delpidio Statement:

On resolution 7 to approve the Sterling tuition, I am voting a soft no, an awareness NO. I Know nothing can be

changed at this moment. I understand that these tuition costs are set by a state formula. However, the choice of school is set by us. We go to sterling high school for 3 reasons.

- 1. Its close and we have become accustomed to it.
- 2. We believe it is the cheapest due to a lower bussing expense.
- 3. We don't know or have anyone with the knowledge in the process of changing it. Next year we need to do a deep dive and make sure this is the best option for Laurel Springs.

They're school districts in this county that produce MUCH better higher education diploma results then Stratford/Somerdale. This is not news to anyone, the school board three or four years ago tried starting the process and got spooked early because they were infected by the idea of possible lawsuits from Stratford/Somerdale. I find that amusing considering Stratford/Somerdale had no problem acquiring hinella from Collingwood not to long ago. I also find it sad we allowed fear of the unknown to obstruct the potential possibility of enhancement.

My soft no transitions to a hard no on resolution 12, appointing Wade, Long, Wood & Kennedy as Solicitor. Where are they when we need legal advice? The school board should have direct Monthly access to the Solicitor. With all the uncertainty and rules and jargon and laws how have we allowed this to go on for so long. We need more knowledge in this room. Every month someone should be here to answer and navigate us through our legal questions. This essential position is not the place that you cut cost. This idea of communicating to our solicitor through our Superintendent is wrong. I do not know who hired them, but we need to hire someone for us. I am pleading that we as a board vote no on 12 tonight. Not next meeting not tomorrow we start looking for a new solicitor immediately. Mr. President please allow us to vote for resolution 12 separate from the rest of the agenda. So that those who may have voted yes can reconsider the idea of stale no show solicitor.
