Mr. Attanasi explained this is required data from 7/1/21 through 12/31/21 based on the drug, HIB training and anti-bullying efforts the districts make. Laurel Springs offered eight programs for students and two teacher trainings. The top score available is 78, Laurel Springs scored 72.

Covid-19 Statement:

The Laurel Springs BOE understands that the COVID-19 pandemic has upended schooling around the world. However, closing schools to in-person education is undermining academic progress and exacerbating educational inequalities. There is abundant evidence that schools can safely open for in-person learning during the pandemic. Here in Laurel Springs our layered mitigation measures have been very successful and we will continue to uphold these measures throughout the course of every school day.

Layered Mitigation Strategies: Our strategies our organized into (3) categories

- 1. Personal Strategy:
 - Vaccinations, wearing masks
 - Staying 3-feet apart
 - Staying home when Sick, washing our hands
- 2. Environmental Strategy:
 - Ventilation mitigation (Air-purifiers)
 - Seating in the same direction
 - Hand-hygiene resources in all classrooms
 - Being outdoors for lunch, recess, mask breaks, etc.
- 3. Administrative:
 - Point person regarding covid (School nurse)
 - Contact tracing protocols
 - Staggered lunches or lunches in the classroom, dismissal, hallway traffic

Dr. Woldoff asked whether the district will participate in test to stay? Mr. Attanasi stated that at this time, we are not. Mr. Attanasi explained that the CDC didn't approve the 5 day change for schools. He also stated that Lisa Corrigan, School Nurse, is doing a great job with managing the load of Covid cases and keeping the students in school.

Mrs. Straub asked whether a child is able to be remote if they are out. Mr. Attanasi said students can synchronously learn and stream. Dr. Woldoff clarified that students can pop in, Mr. Attanasi said yes. Mr. Brisbin thanks Mr. Attanasi for all of his work for the school and all he has done.

Dr. Woldoff asked is there is a plan if there is a staffing outbreak. Mr. Attanasi said yes.

In closing, Mr. Attanasi explained that the NJ Government doesn't allow for weather to count as a remote school day. Therefore, with reduced custodian staff decisions on snow days will be made based on the meteorologist.
