- 1. This morning I attended a meeting with the Camden County Prosecutors office. During the meeting, the notion of cell phone and social media accessibility was presented. Please be vigilant in your monitoring of your son or daughter's accessibility and usability of apps such as snapchat, Instagram, tik tok, Kik, discord, and whatsapp to name a few that were presented. I will be sending a list of apps that parents should be aware of in the next newsletter. Many times, students think they are talking to peers and exchanging photos, but these can easily fall into the wrong hands. Please be aware of who your children are talking with on home gaming systems as well. There have been reported incidents of people luring children into exchanging phone numbers and conversations can lead to pictures being exchanged.
- 2. On March 15th we held our annual school wide bowling trip. All students seemed to have an excellent time bowling with their friends and classmates. I would like to thank the HSC for sponsoring the event. Upon arrival back at school we conducted bus evacuation drills with all students.
- HVAC Project Update- We will be looking to send this project out for bid and awarding a contract at or before the May BOE meeting. This project would replace all of the HVAC units in the building and will be funded through ROD grant funding and local funds.
- 4. Fence Project Update- This project has been completed.

- 8. On February 29th I attended a meeting at Sterling HS to discuss ways to share services. Topics discussed included world language teachers, transportation, and special education. These meetings are designed to help share costs as well as services.
