




#### Comparison of Laurel Springs School's Subgroup Spring 2023 and Spring 2024 NJSLA Administration English Language Arts - Percentages

# **Notable Achievements**

- Increased percentage of students scoring Level 4 or 5 in ELA in 3 out 4 grade levels (3<sup>rd</sup>, 4<sup>th</sup>, 6<sup>th</sup>)
- Notable increase in achievement for the current 4<sup>th</sup> grade cohort compared to their 3<sup>rd</sup> grade ELA scores (from 28% to 70%)
- Increased percentage of 3rd grade Math students meeting or exceeding expectations (from 42% to 58%)



# **Intervention Strategies**

• Explore needs in Math:

oIn grade 5, the percentage of students in Levels 1 and 2 increased from 12% to 23% in 2024.

oIn 4th grade, the percentage of students meeting or exceeding expectations dropped from 58% to 39%

• Explore subgroup performance which shows economically disadvantaged students and students with disabilities underperforming in both Math and ELA.
