



Comparison of Laurel Spring School's Subgroup Spring 2024 and Spring 2025 NJSLA Administration English Language Arts - Percentages








Comparison of Laurel Spring School's Subgroup Spring 2024 and Spring 2025 NJSLA Administration Math - Percentages







Notable Achievements- ELA

- Grade 5: Significant improvement in students "Meeting" or "Exceeding" expectations from 64% to 88.5%, while Levels 1–2 decreased from 16% to 3.8%.
- Grade 6: Increase in students at Level 4 ("Meeting Expectations") from 44% to 55.6% and maintenance of high performance at Level 5 (22.2%).
- Laurel Springs' district results outperformed or matched state averages in Levels 4–5 across several grades, showing effective literacy instruction and consistency in comprehension and writing outcomes.



Notable Achievements- Math

- Grade 4: Level 4 proficiency increased from 39% to 47.6% a strong indicator of gains in problem-solving and conceptual understanding.
- Students with disabilities demonstrated measurable improvements in pass rates from 2024 to 2025, reflecting success in targeted support programs with a focus on support to access grade level content.
- Grade 3: Increase in "approaching expectations" (Level 3) from 21% to 32% indicating more students are moving toward proficiency.



Intervention Strategies



Tier 1 Instruction:

- Launch of Professional Learning Communities (PLCs) focused on Tier 1 instruction, in collaboration with Inspired Instruction coaching team.
- PLCs emphasize data-driven decision making, consistent use of standards-based lesson planning, and shared teacher reflection to refine core instructional practices.

ELA

- Target Grades 3–4 for Tier 1 instructional support to reduce students in Levels 1–2.
- o Implement small-group guided reading, vocabulary building routines, and writing workshops aligned with grade-level standards.



Intervention Strategies



Mathematics:

- OUtilize spiraled review and math fluency routines in all grade levels (3-6).
- oAdopt a new, research-based mathematics program in alignment with NJSLS and the district's Professional Development focus
